

OFFICIAL NOMINATION AND ELECTION NOTICE

FOR

WISCONSIN CHILD CARE PROVIDERS TOGETHER LOCAL 373, AFSCME, AFL-CIO

This will serve as official notice to all AFSCME Local 373 members that nominations will be accepted and elections will be held, if necessary, for the following delegate and local union officer positions:

- I. **Election of Delegates to the AFSCME Council 40 Convention, April 16 - 18, 2010, Madison, Wisconsin.** Local 373 is entitled to send nine (9) delegates. Nominations must be received by **March 2, 2010**. If an election is necessary, ballots will be mailed to all members no later than **March 17, 2010**. Marked ballots must be received by the local no later than **March 31, 2010**. If there are more than nine (9) nominees, the nine (9) nominees receiving the greatest number of votes will be delegates and the remaining nominees, up to a maximum of nine (9), will be alternates. **The Local 373 Executive Board has approved a maximum expense reimbursement of \$200.00 per delegate for this convention.**
- II. **General Officers Election.** Local 373 will elect a president, a vice president, a secretary, a treasurer, eight (8) executive board members, and a trustee to two year terms of office in May, 2010. Nominations for these offices must be received no later than **April 9, 2010**. Nominations for these positions will also be accepted from the floor at the annual meeting on **April 17, 2010**. If an election is necessary, ballots will be mailed to all members no later than **April 30, 2010**. Marked ballots must be received by the local no later than **May 17, 2010**. If a runoff election is necessary, runoff ballots will be mailed to all members no later than **May 28, 2010**. Marked runoff ballots must be received by the local no later than **June 14, 2010**.
- III. **AFSCME International Union Convention, June 28 - July 2, 2010, Boston, Massachusetts.** Local 373 is entitled to send four (4) delegates. Nominations must be received by **April 9, 2010**. If an election is necessary, ballots will be mailed to all members no later than **April 30, 2010**. Marked ballots must be received by the local no later than **May 17, 2010**. **The Local 373 Executive Board has not approved any expense reimbursement for this Convention. The Local 373 President by virtue of his/her seat on the Council 40 Executive Board will, however, have his/her expenses reimbursed by Council 40.**

A list of all nominees will be posted on the AFSCME Local 373 website following the nomination deadline. Any nominee who wishes to decline a nomination must so notify the Elections Committee per the contact information noted above by no later than March 8, 2010 if the nomination is for a delegate to the Council 40 Convention or by April 24, 2010 if the nomination is for an officer position, trustee, or delegate to the International Union Convention.
